- a) This Permit is **solely** for activities relating to the Purpose of Visit on the Specified Area or Route of Owhaoko B&D Trust Lands, this being private land and such Permit must be carried by the Permit Holder at all times during the Period of Visit & is only valid for these dates;
- b) This Permit confers no right to: (i) cut or fell any living trees or shrubs, or (ii) kill or remove any native fauna or flora including eels; all huts & campsites must be left clean & tidy, and all rubbish & unused food items removed from Trust Lands by the Permit End Date;
- c) The Permit Holder will at all times abide the environmental and health & safety notices & policies of Owhaoko B&D Trust and Helisika Ltd, including: (i) where applicable the relevant fish & game regulations, and (ii) the ban on lighting of fire in open areas;
- d) This Permit shall act as a biosecurity obligation to check & clean all items brought on Trust Lands, & a trespass notice to all surrounding areas or blocks which are private land – it is the Permit Holder's responsibility to identify & remain clear of surrounding boundaries; and
- e) Disclaimer: Subject to any NZ statute which may apply the Owhaoko B&D Trust [being the registered proprietors of the land for which this permit applies] and Helisika Ltd [helicopter service licensee] accept no liability for any injury, damage or loss to the Permit Holder

Owhaoko Deer Kill Policy

- No shooting at night or use of thermo vision
- No more than 3 Sika hinds per person
- No shooting Sika stags in velvet
- No shooting of Sika spikers
- No limit on shooting of Red deer
- No use of dogs without specific approval
- Total kill of Sika stags is 4 per party inclu. only one 8 pointer per person
- Carcasses / offal to be disposed of at least 100m from campsites, huts & waterways
